ORIX Credit Malaysia Sdn Bhd (Company No. 198101000999 (67108-U)) (the "Issuer")

Commercial papers programme of up to RM500.0 million in nominal value, which together with a medium term notes programme of up to RM1,500.0 million in nominal value, have a combined limit of up to RM1,500.0 million in nominal value ("CP Programme")

Reference is made to the trust deed dated 16 March 2020 ("Trust Deed") made between the Issuer and Malaysian Trustees Berhad as the Trustee, in relation to the CP Programme. The terms and conditions used herein, unless otherwise defined, shall have the same meanings as defined, interpreted or used in the Trust Deed.

1. Pursuant to the relevant amendment to the SC Lodgement where the first issuance of CPs can be made within sixty (60) Business Days from the date of SC Lodgement or such other extended date as may be granted by SC in line with the SC's announcement in relation to the movement control order, we write to request that from the date of this letter, the Trust Deed shall be amended as follows:

1.1 Recital E of the Trust Deed

- (a) Recital E of the Trust Deed shall be deleted in its entirety and replaced as follows:

"The first issuance of the CPs under the CP Programme shall be made within sixty (60) Business Days (as defined in clause 1.1 (Definitions) below) from the date of SC Lodgement (as defined in clause 1.1 (Definitions) below) pursuant to the LOLA Guidelines (as defined in clause 1.1 (Definitions) below), or such other extended date as may be granted by SC, whereby lodgement has been made on 12 March 2020 with the SC for the Issuer to establish the CP Programme and to issue the CPs under the CP Programme."

1.2 Clause 1.1 of the Trust Deed

- (a) The definition of "Issue Date" under clause 1.1 (Definitions) of the Trust Deed shall be deleted in its entirety and replaced as follows:

"Issue Date *in relation to each Tranche of CPs, the date of issue of that CPs which shall be a Business Day, where the first issue date shall be no later than the date falling sixty (60) Business Days from the date of SC Lodgement, or such other extended date as may be granted by SC."*

- (b) The definition of "Programme Tenure" under clause 1.1 (Definitions) of the Trust Deed shall be deleted in its entirety and replaced as follows:



"Programme Tenure *the tenure of the CP Programme which shall be a period of seven (7) years from the date of the first issuance of the CPs under the CP Programme, provided that the first issuance of the CPs shall be made within sixty (60) Business Days from the date of SC Lodgement, or such other extended date as may be granted by SC."*
